

Model Release

In consideration paragraph (h) of this agreement and of my engagement as a model, upon the terms herewith stated, I hereby give to Starmaker Productions, *BluegrassBabes.com*, (hereafter referred to as *BluegrassBabes.com*) their heirs, legal representatives and assigns, those for whom *BluegrassBabes.com* is acting, and those acting with *BluegrassBabes.com's* authority and permission:
